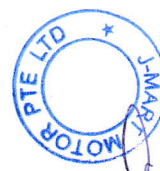

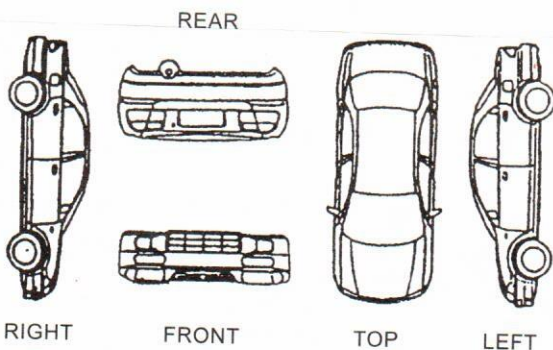

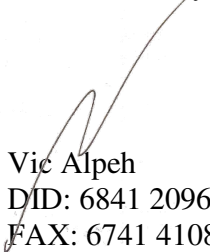
We have received a claim from Body Repairer/Workshop acting on behalf of the owner of EP 231G against your motor insurance policy.
