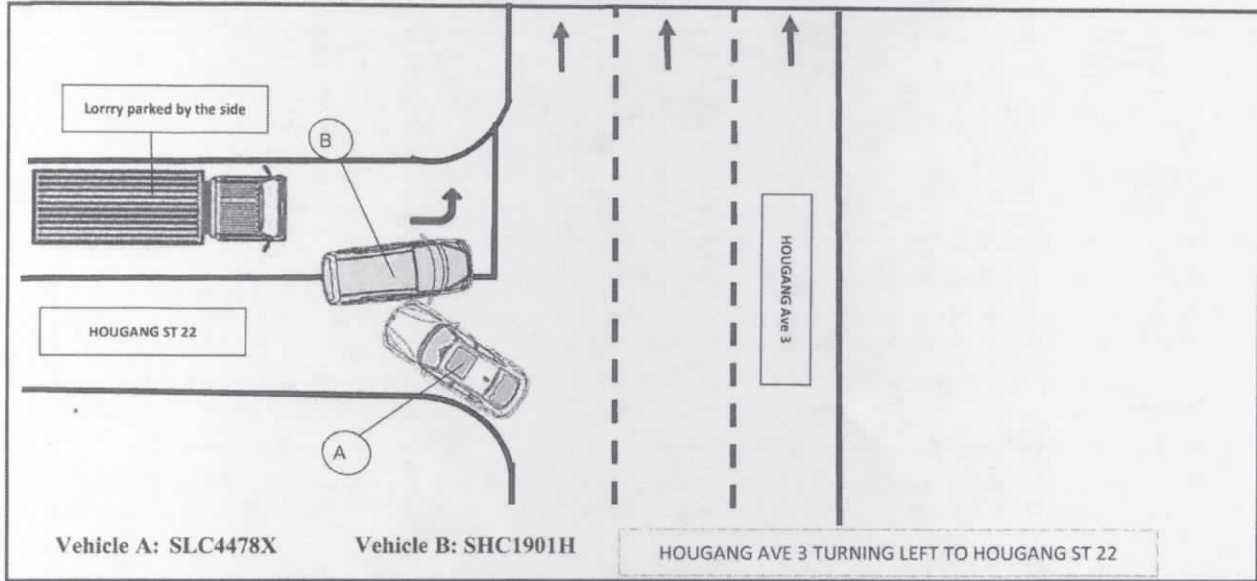

SKETCH PLAN

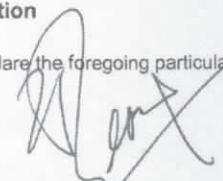


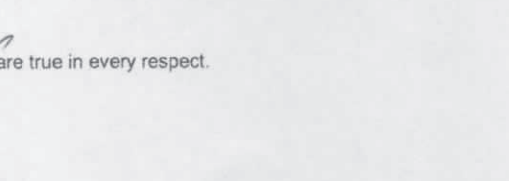

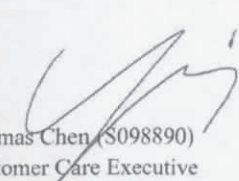
I was turning left into Hougang St 22 and the front right of my car collided with the right side of Vehicle B.
