

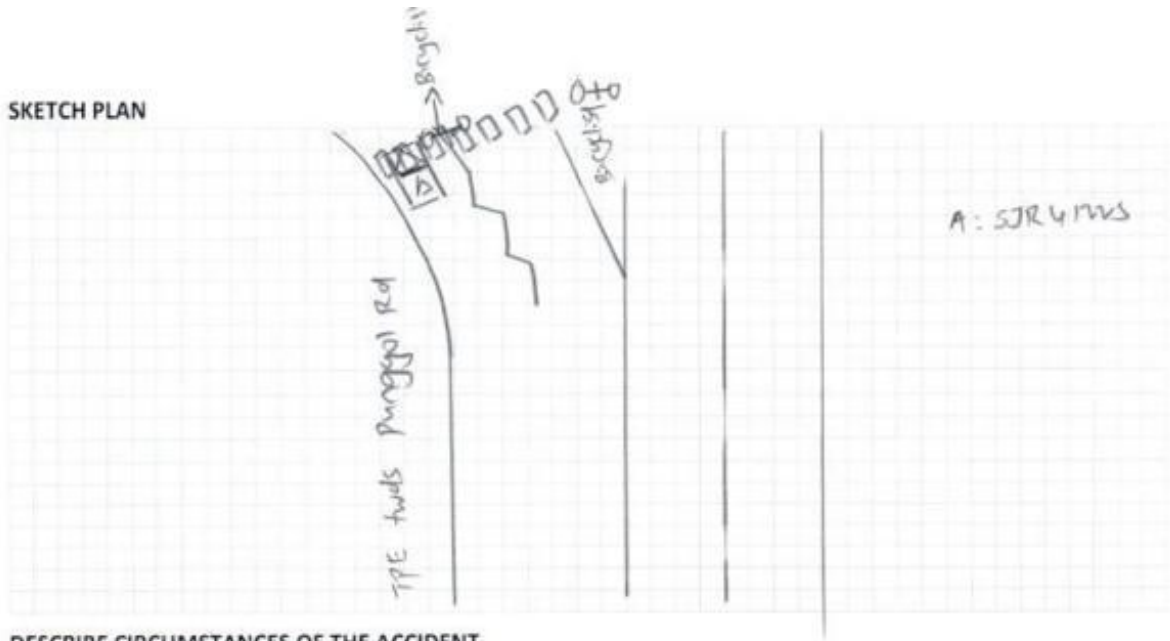

CONTINUATION OF REPORT

Brief Details.

On the 9th January 2020 at about 0758hrs, I was driving my vehicle SJR4122S along TPE filter lane and turning left towards Punggol Road near Blk 203B. I was on the left lane of a 2 lane road. I stopped at a zebra crossing to allow some pedestrians to cross the road from the left to the right. Once the pedestrians had crossed the road, I proceeded to drive off. Suddenly, one male Chinese who was riding a bicycle from the right side, tried to cross the road. I was unable to brake on time and as such my vehicle hit the cyclist. The cyclist fell down. I went out of my vehicle and assisted the cyclist. After which, I called the ambulance and police. Subsequently, the ambulance arrived at scene followed by the Traffic Police officers.
