Brief Details.

On 11/12/2019 at 1603hrs, I had lodged a Road Traffic Accident Report reference to T/20191211/2116. I am currently lodging this report for amendment

On 09/12/2019 at about 1900hrs, I was riding on gold colour 'HONDA' motorcycle bearing of registration number: WGK 5389 on the utmost right lane of the Seletar Expressway. While I was travelling along the said lane, there is one unknown lorry switched to my lane in a fast manner and collided onto me. I then fall off from my motorcycle. I was semi-conscious and unsure what had happened during the incident. I then saw one passer-by came to assist me. Subsequently, I was conveyed to Khoo Teck Puat Hospital.

I was admitted on the same day and discharged on 11/12/2019. I was given a total of 17 medical leave from 09/12/2019 to 25/12/2019.

I suffered abrasion on my left cheek region, rear left heel, swollen on the right wrist and fractured on my left arm.

On 19/12/2019, I had went to Khoo Teck Puat Hospital for follow up on my fractured arm and was applied with plaster. I was given 8 days of medical leave from 19/12/2019 to 26/12/2019.

I am required to go back to Khoo Teck Puat Hospital again for to review on my fractured arm.
