**Brief Details.**

On 09/01/2020 at about 0645hours, I was driving (SMF7527R) along Hougang avenue 10 on the most extreme left lane and everything was fine. As I was travelling straight, suddenly one vehicle SKU6502M had cut into my lane from the right lane and applied brake immediately. As the brake was too abrupt, I was unable to stop in time thus colliding on to the rear of the vehicle. I got down of my vehicle and spoke to the driver whom informed that he is apologetic for the accident and the reason for him changing lane so abruptly was because there was a vehicle in front of him wanting to turn right as a result he had to swerved into my lane which then caused the accident.

At that point in time, as nobody was injured no traffic police was called upon and no ambulance was needed.

I then reported the matter to my insurance however on the 31/01/2020 at about 2015hrs, I opened my mail box and noticed a letter from Traffic Police addressing to me stating that I am required to lodge a Traffic Accident Report with regards to reference number : TP/IP/04519/2020.
