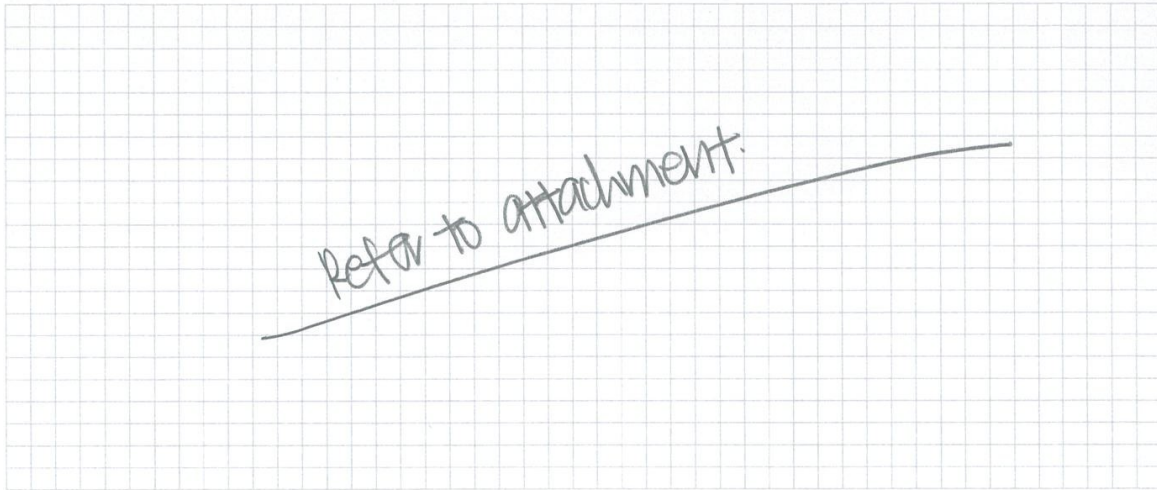

SKETCH PLAN



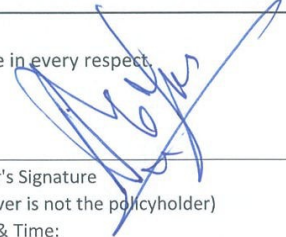

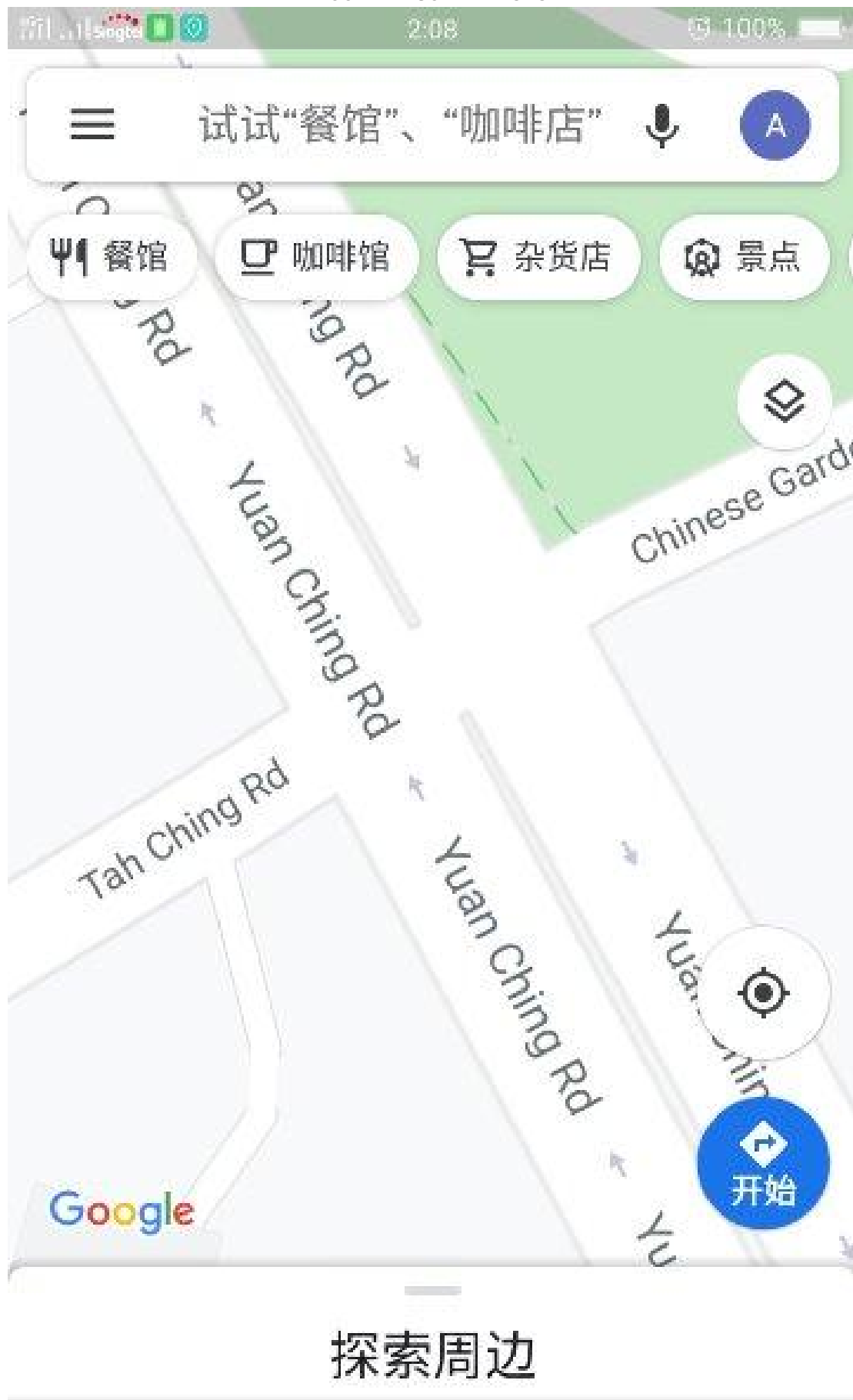
