#straightroad Moving straight & Moving straight Blue Car SFQ6626U White Car SLF7134C I was travelling along Tampines Ave 10 in the direction of Pasir Ris approaching the traffic junction before Tampines Fire Station. There were a few cars in front of me which were moving off when the traffic light turned green. I did not realise that the car in front of me was still stationary and my car hit his lightly. The other party's car plate number is SLF 7134 C. The driver Lim Woh Him NRIC S1512099A came out of the car and hurled vulgarities at my wife. She offered to have him send his car which he claimed is badly damaged and requires minimum 3 days of repair to our private workshop. However he was not very happy so we left the scene after exchanging particulars. He called me later and insisted for compensation if he sends his car to our private workshop. My car is not damaged and his car is fine too. I offered that he reports to the insurer since he is so demanding. He said he will discuss the matter with his wife and give us an update last night. 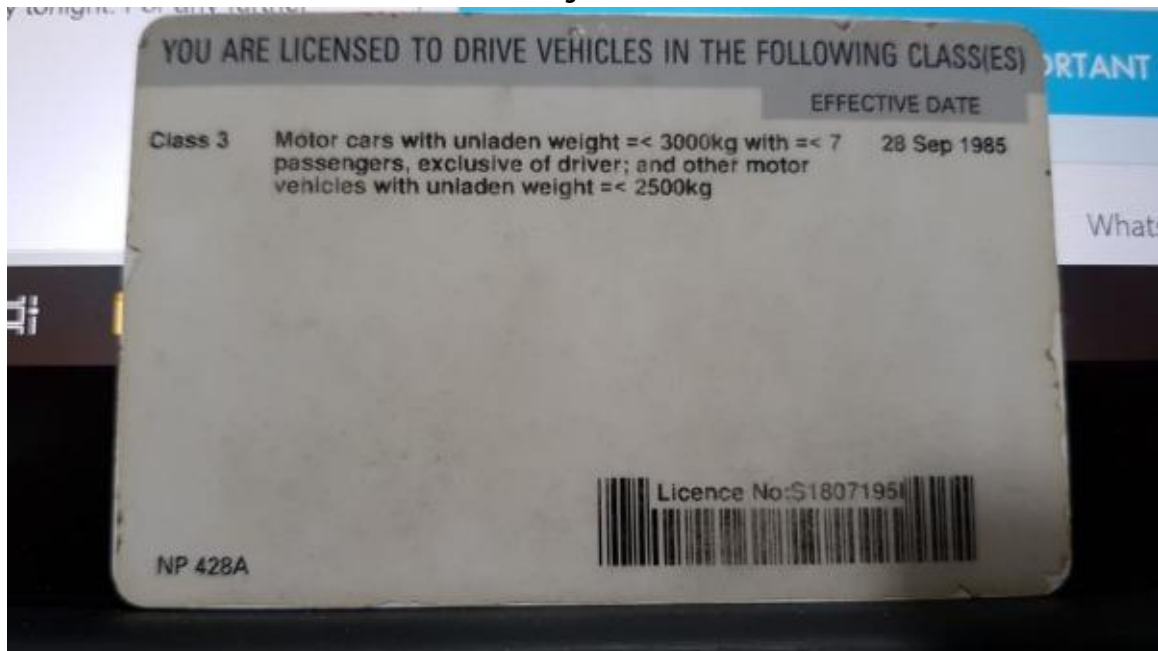
