AT ABOUT 5:55PM, I WAS ON THE SECOND LANE FROM THE RIGHT ALONG SOUTH BUONA VISTA ROAD WAITING TO TURN RIGHT INTO KENT RIDGE ROAD. WHEN THE TRAFFIC LIGHT TURNED GREEN, I DO NOT SEE ANY ON COMING VEHICLE, SO I STARTED TO TURN. THAT WAS WHEN I SAW A MOTORBIKE COMING TOWARDS ME FROM METERS AWAY. I STOPPED MOVING IMMEDIATELY AND THE THE RIDER VISIBLY TRIED TO BRAKE. THE MOTORBIKE COULD NOT STOP IN TIME AND BANGED INTO THE FRONT LEFT OF MY CAR. I SAW THE RIDER DISEMBARKED FROM HIS BIKE AND SLOWLY LAY HIS BIKE ON THE ROAD. THE WAS NO INJURY. A DOCTOR PASSING BY STOPPED AND CAME TO CHECK IF THERE WAS INJURY. HE LEFT ONLY AFTER THERE WAS CONFIRMATION THAT THERE WAS NO INJURY. IN THAT MOMENT, I FORGOT TO ASK FOR THE PARTICULAR OF THE DOCTOR.

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

At about 5:55 pm, I was on the second lane from the right along ^{South} Buona Vista Road waiting to turn right into Kent Ridge Road. When the traffic light turned green, I do not see any on-coming vehicle, so I started to turn. That was when I saw a motorbike coming towards me from about 10 meters away. I stopped moving immediately and the rider visibly tried to brake. The motorbike could not stop in time and barged into the front left of my car. I saw the rider dismounted from his bike and slowly lay his back on the road.

There was no injury. A doctor passing by stopped and came to check if there was injury. He left only after there was confirmation that there was no injury. In that moment, I forgot to ask for the particulars of the doctor.

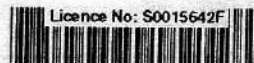
