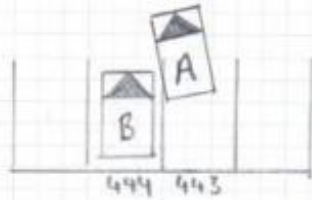

### **Brief Details.**

On 06/01/2020 at about 1630hrs, I was driving my vehicle bearing registration : GBE4991M, a blue Nissan Cabstar out from lot number 443 of Blk 421 Bukit Batok West Ave 2 when I met with an accident.

I was going on from the carpark lot, after checking on the left that the traffic was clear, I checked on my right and proceeded to inch out when suddenly, I heard noises on the left of my vehicle. I discovered that I had side swiped a blue color Nissan bearing registration: SKR5442A at lot 444. Immediately, I informed my company who subsequently made effort to contact the car owner. I was advised by the Police to lodge a traffic accident report reference to report J/20200106/0103.

My vehicle sustained little to no damages.

The vehicle, SKR5442A, sustained quite serious damage. The side panel on the driver side was heavily bent with damages to the engine hood and front vehicle light assembly as well as the front grill. The front bumper is dislodged. I had one passenger with me at the point of incident.
