I am commonly known as Yusof. I am currently working as a cleaner. I am driving a motorcycle with vehicle plate number FBE8353D.

On 05/05/2019 at about 0800 hrs, I was travelling along Seletar Expressway. Suddenly, I was collided on the rear side of my motorcycle by a car which resulted me to flew forward. I was still conscious however the impact resulted to be unable to understand what happen throughout the situation. The police and ambulance was at scene and I was conveyed to Khoo Teck Puat Hospital. I was warded in the hospital from 05/05/2019 to 08/05/2019. I was also diagnosed with 35 days of MC.

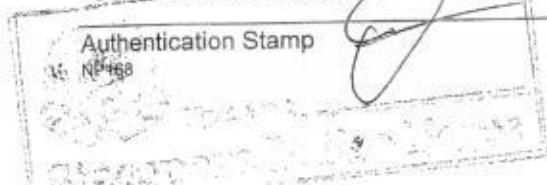
