Dear Sirs/Mdm,

We refer to the above matter.

We have reviewed the matter and based on all the available information on hand, we are of the view that we do not have a good defense towards the claim submitted by the owner of SLJ2624S. Kindly refer to the attached video from SLJ2624S for your easy reference. We observe that third party was driving within his own lane, your vehicle changed lane and collided onto third party. Under Motor Accident Guide, vehicles should keep in the proper lane and change lane only when it is safe. As such, we are of the view that liability is not in your favour. We shall proceed to negotiate for an amicable settlement of the third party claim at best to avoid further litigation, which would escalate to even more cost.
