



LEASING AGREEMENT (2)

Section C: Terms & Conditions

1. This vehicle is restricted to Singapore use only. In the event the Hirer wishes to enter into Malaysia, he/she shall prior to entering Malaysia inform JACK CARS ENTERPRISE PTE LTD and sign up for the appropriate insurance and shall be liable to the terms and conditions set out by JACK CARS ENTERPRISE PTE LTD.
2. This vehicle is restricted to carry passengers only.
3. Hirer's Responsibilities:
 - a. The Hirer shall be responsible to pay for the first \$3,000 to \$10,000 damages or costs of repair for each and every accident the Hirer is involved in with the vehicle.
 - b. The Hirer shall be responsible for any loss of earnings by JACK CARS ENTERPRISE PTE LTD for the duration the damaged vehicle is undergoing repair.
 - c. The Hirer should note that the insurance policy covers only claims from third parties.
 - d. The Hirer shall be liable for all claims and/or damages arising from use of the vehicle involving and illegal activity, driving whilst under the influence of alcohol or any other immoral or illegal activity that is not covered by the motor insurance policy taken by JACK CARS ENTERPRISE PTE LTD.
 - e. The Hirer shall bear all liability if it is found that he/she had hired the vehicle through fraud, or impersonating, or sub-leasing.
 - f. The Hirer shall bear all costs incurred in case of a breakdown for all the parts that are not covered under the insurance wear and tear, eg. flat battery, or flat tyre.
 - g. There shall be no replacement of a vehicle in the event of a breakdown.
4. The Hirer shall bear all ERP charges, parking fees, and traffic fines. The Hirer shall bear responsibility in the event a traffic offence is committed whilst the vehicle is on hire.
5. Any traffic fines and parking charges or any other fees paid on behalf of the Hirer by JACK CARS ENTERPRISE PTE LTD will have a surcharge of \$30 as a service charge and be claimable from the Hirer.
6. Extension of Leasing Period:
 - a. The Hirer has to give one day's notice prior to the extension of the leasing period and must first sign the extension form.
 - b. Extension of lease is subject to the availability of the vehicle.
7. A surcharge of \$30 per hour shall be levied on any vehicle returned after the stipulated returning time.
8. JACK CARS ENTERPRISE PTE LTD shall not be responsible for any injuries, loss of life or damage of any kind to any person or thing involving the vehicle during the term of the lease. The Hirer alone shall be responsible for all such events.
9. The Hirer admits or has sought parental consent before renting the car from JACK CARS ENTERPRISE PTE LTD should he/she be below 21 years of age.
- h. There should not be a sub-leasing of the vehicle to anyone during the rental as long as the vehicle is rented from JACK CARS ENTERPRISE PTE LTD. If the hirer is found sub-leasing the vehicle to another person during the rental, the Hirer shall bear full responsibility for all claims and/or damages arising from use of the vehicle involving any illegal activity.
