On 09/01/2020, at about 13:30 hrs, my vehicle was traveling along Serangoon Road in lane 2. The weather was clear with dry road surface area at that point of time. As I was traveling within my lane, a vehicle SHC8422C in lane 1 suddenly moved off from his stationary position, encroached into my lane and grazed against my bus. As a result, my bus sustained grazing damages on front right bumper while SHC8422C sustained damages on the front left portion. No one was injured.


