On 13/01/2020, at about 18:37 hrs, I was driving my company bus bearing registration number PA9781A along Yishun Ave 1 towards Yishun Ave 8. I was on the right lane of a two lane road. As the traffic was heavy, all the vehicles had slowed down. Subsequently, the vehicle ahead of mine had stopped his vehicle, thus, i stopped my vehicle too. Thereafter, there is one blue company AEDGE coach bearing registration number PC3588X from my rear had collided onto my bus. Thus, I had collided one white vehicle Mercedes SKP933T which was in front of me. The said vehicle had then collided his front vehicle YL3464R. No one was injured in the accident. As a result, my bus sustained damages on the rear bumper, the both rear headlight and the rear engine cover.

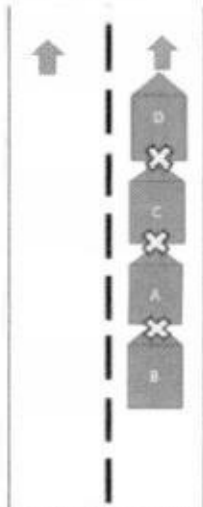

As the traffic is heavy, all the vehicles had slowed down. Subsequently, the vehicle ahead of mine had stopped his vehicle, thus, I stopped my vehicle too. Thereafter, there is one blue company 'AEDGE' coach bearing of registration number: PC 3588X (with passengers) from my rear had collided onto my vehicle.

Thus, I had collided one white vehicle 'Mercedes' bearing of registrations number: SKP 933T which was in front of me. The said vehicle had then collided his front vehicle bearing of registration number: YL 3464R (with passengers).

No one was injured. No ambulance or police called in.

The weather is clear and was not raining. No road construction took place.

All parties came out of their own vehicles. I had asked for the driver particular (SKP 933T) who refused to provide. I had exchanged particulars with the driver (PC 3588X).
