  - (iii) in complying with requirements under any regulatory laws or court orders.



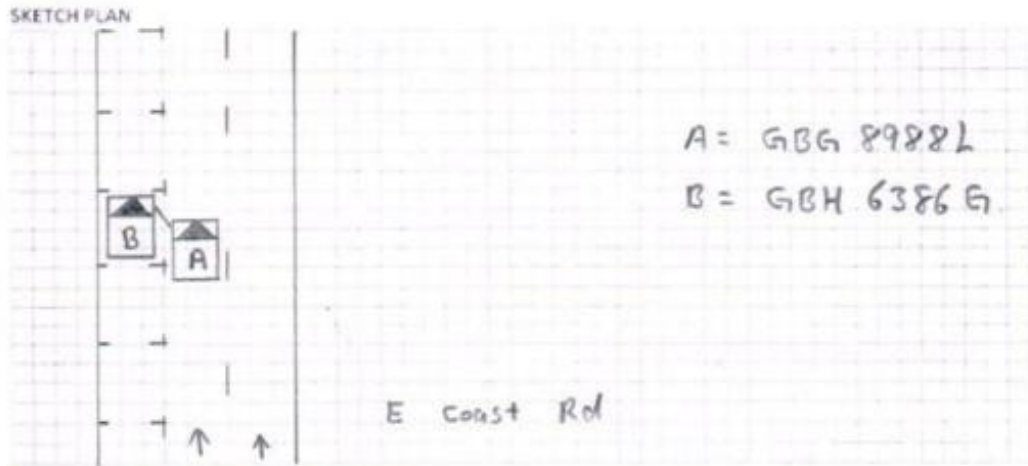
