# AFFIDAVIT OF EVIDENCE IN CHIEF (LIABILITY)

I, LIM DAOLIANG ELIJAH (NRIC No S 9138094C) of 18 Jalan Pakis Singapore 678 603 hereby affirm/make oath and say as follows;

- 1 I am the Plaintiff in this action.
- I make this Affidavit in support of my claim for compensation for my personal injuries, losses and expenses arising from a traffic accident on 22<sup>nd</sup> day of July 2016 and I say that the contents herein are true and unless otherwise stated are true to the best of my knowledge information and belief.
- On the 22<sup>nd</sup> day of July 2016 at about 7.50 pm, I was riding my motorcycle FBG 9259B straight on Lane 2 at about 60kmh to 70kmh along the Pan Island Expressway ("said Expressway") towards the direction of Changi Airport.
- Somewhere before the Eunos exit, traffic started to slow down and a motor vehicle infront of me applied his brakes and I also applied my brakes and as I was slowing down, a motor van GU 1662P that was driven by the Defendant

and that was travelling behind suddenly collided into the rear of my motor cycle. As a result of the said collision, I loss control of my motor cycle and skidded and fell onto the said Expressway. When I fell, I hit my face onto the road surface and was a little dazed and lay on the road for awhile until some road users and the Defendant alighted to assist me.

- I later realised that it was a chain collision as there was another lorry YL 8454L that was driven by the Third Party behind GU 1662P as well as another motor cyclist that was involved in the accident. We then moved to the side of the Expressway to exchange particulars. I however did not manage to get the other motor cyclist's particulars before he left.
- At that time of the accident, it was drizzling and the road surface was wet and the traffic was moderate.
- I have seen a copy of the Defendant's Traffic Police Report and wish to say that I was slowing down when the Defendant collided into the rear of my motor cycle. I did not self skid as I was neither speeding or travelling too fast when I applied my brakes and there was ample space and time for me to come to a complete stop otherwise I would have collided into the motor vehicle in front of me when I was hit from the rear by the Defendant or when I "self skidded" (which is not admitted).
- There is really no conceivable reason why I would suddenly self skid when I did not apply my emergency brakes. After all, I have been riding a motor cycle for over 4 years and have never had a traffic accident before. It makes no sense for me, in the absence of any emergency along the road, to just simply skid and lose control whilst travelling straight.
- I maintain my position that the Defendant had collided into my rear as he was either travelling too fast and/or too close to me and/or failed to apply his brakes in time and/or adequately. His negligence caused me to fall and suffer personal injuries.

Annexed as "A" is a copy of my Traffic Police Report as well as a copy of the letter dated 9<sup>th</sup> February 2017 from Traffic Police stating that the Third Party, the driver of YL 8454L, was given a warning for careless driving.

I was later seen at Changi General Hospital and given three (3) days of medical leave.

#### Brief Details.

On 22 July 2016 at about 7.50pm, I was riding my motorcycle, black Bajajpulsar 135, FBG9259B along PIE towards Changi Airport on the second lane of the expressway. Somewhere near to Eunos exit, the traffic slow down and the car in front of me suddenly applied the brake. I then applied my brake too. Unfortunately, while my motorcycle was slowing down, a van collided into my motorcycle from the rear. I lost control of my motorcycle and skidded. I then hit my face on the road surface. I was on the road for a while before some road users and the van driver came to assist me.

Subsequently I noted that it was a chained accident which involved my motorcycle, a van (GU1662P), a lorry (YL8454L) and a motorcycle (unknown registration number). All of us then went to the road shoulder to exchange details.

The driver of the van which collided into my motorcycle only provided me with his contact no: 94601889. He is a male Chinese believed to be in his 40s or 50s. I tried getting his particulars numerous times but he refuses to give me. I did not manage to get the other motorcyclist's detail.

Subsequently 2 persons from the nearby car workshop (Team Work Garage Pte Ltd) who saw the accident came over to offer their help. They had arranged for my motorcycle to be towed and they send me to Changi General Hospital for treatment. I was treated as outpatient and given 3 days of medical
