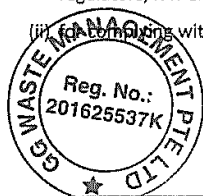

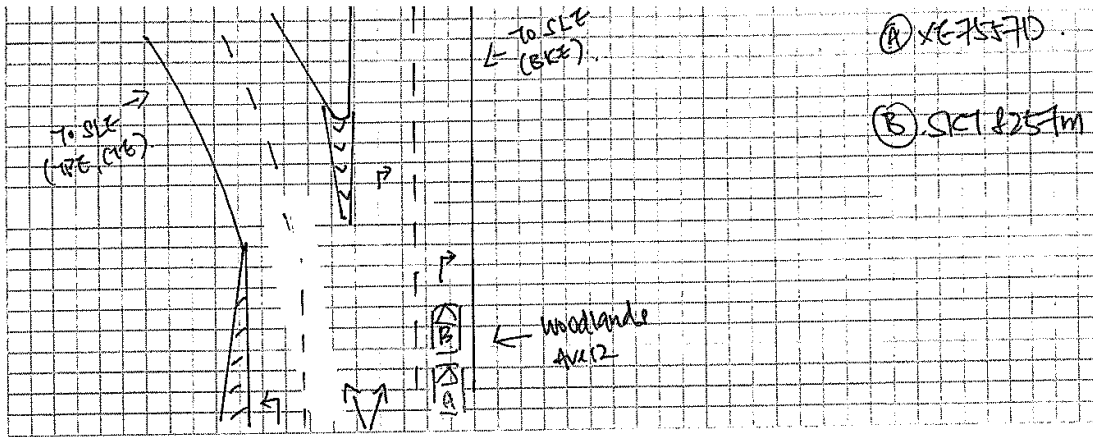

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

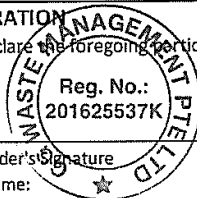
On 17/01/2020 @ around 0930 hrs, I was travelling along Woodlands Ave 12 to SLE (BKE).

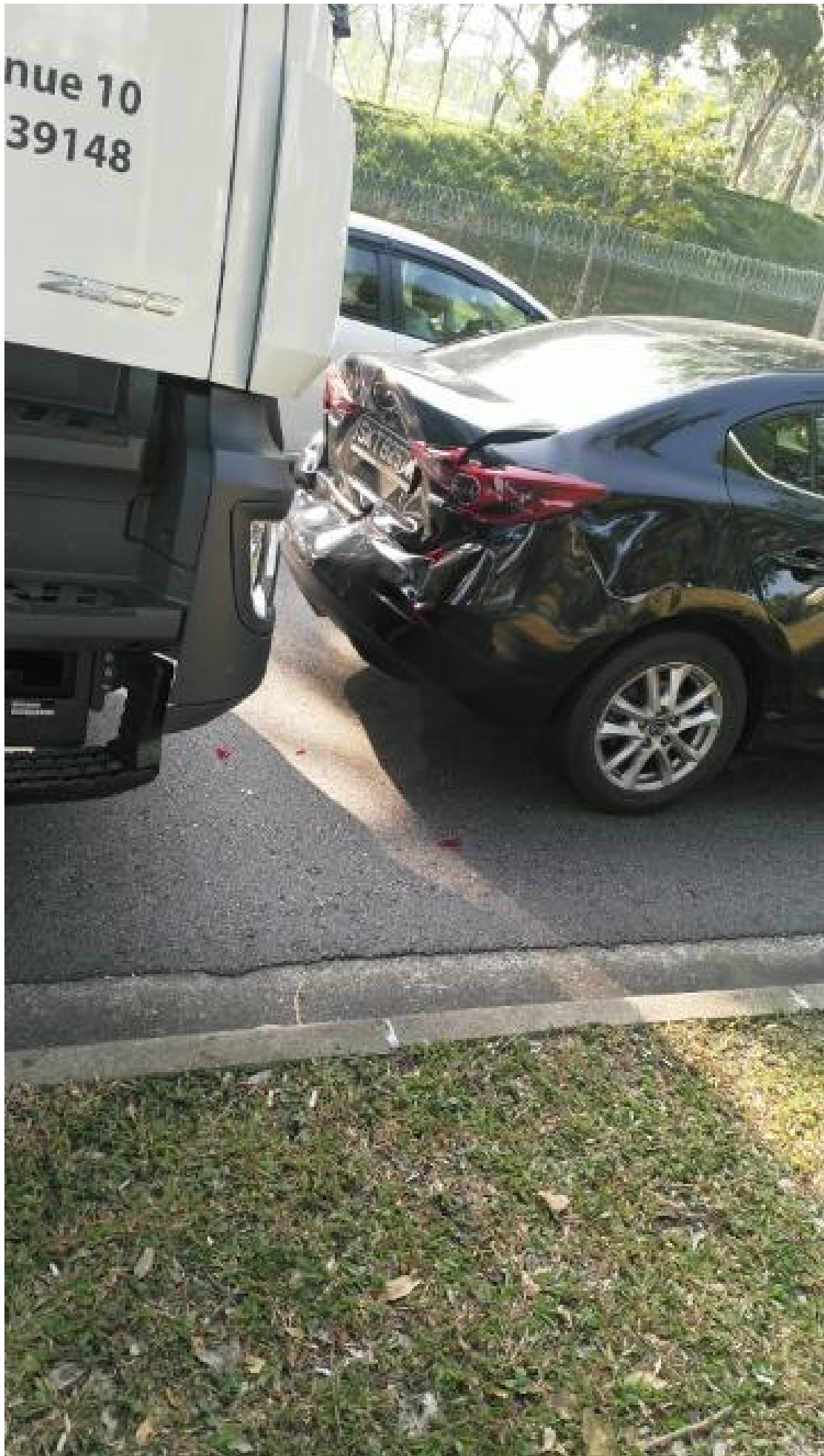
