Brief Details.

I am lodging this Traffic Accident report in ref to F/20200104/0100.

On 14/01/2020 at around 1400hrs, I was travelling along Ang Mo Kio Avenue 5 towards Ang Mo Kio Avenue 8 (near Anderson Secodary School) in the first lane of a three lane road. As the traffic light ahead was red, my car (V1: SKN9645B) was stationary and in queue with about 5-6 other vehicles in front of me. Suddenly a vehicle (V2: SHA7925K) sped past on my right side and collided onto my right side mirror, the said vehicle was travelling on same lane and went on to change lane to my right (filter lane. right turn only). After the collision, the said vehicle did not stop and instead continued driving before turning into the vicinity of Nanyang Polytechnic. I followed V2 before calling for police assistance as the driver of V2 refused to give his particulars and claimed that accident happened due to my fault.

Due to the collision, my vehicle right side mirror was broken. Subsequently, I went to Raffles Medical at Northpoint and received 2 days MC (Ref G07420001221) from 14 Jan 2020 to 15 Jan 2020 due to my injuries (Pain on right arm, due to shock) . I wish to state that I have in-car camera footage of the accident and I will be making a case with my insurance company.
