We refer to the above subject matter. We write to inform you that we are the loss adjuster appointed by your motor insurer, AIG Asia Pacific Insurance Pte Ltd to deal with the third party claim against your policy.

Please be informed that we have reviewed both reports and based on accident scenario & all available information at hand for the accident, wherein you are being charged by the traffic police for “**Careless Driving Under section 65(1)(a) Of The Road Traffic Act Chapter 276^h.**” We are of the view that we do not have a good defense towards the claim submitted by the owner of SFF 380A and it is quite difficult for you to escape liability of the collision.

Should you however wish to further discuss on the matter prior to our negotiations and settlement, please contact us within 7 days from the date of this letter.


