

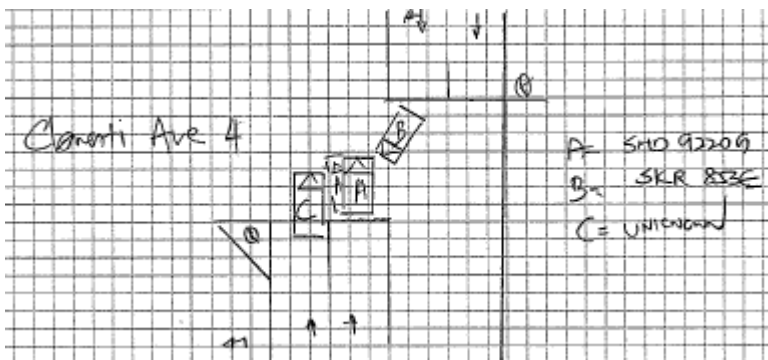

Brief Details.

ON 16/1/2020 AT ABOUT 1955HRS I WAS TRAVELING ALONG CLEMENTI AVE 4 TOWARDS CLEMENTI AVE 3. AT THE JUNCTION OF CLEMENTI AVE 4 AND AVE 5 THERE WAS A TRAFFIC JUNCTION.

AS THE GREEN LIGHT WAS IN MY FAVOUR, I PROCEEDED TO MOVE FORWARD SLOWLY. AS I WAS AT THE CENTER OF THE JUNCTION A CAR (SKR853E) SUDDENLY CAME INTO MY LANE FROM THE OPPOSITE DIRECTION FROM CLEMENTI AVE 4. I QUICKLY APPLIED MY BRAKES AND PREVENTED THE COLLISION.
