Good Afternoon.

Attached please find with the Legal Letters fr0m the APAC Law Corporation to the u/m accident involving my wife's vehicle SMH 8028Y and SMR 5626M. I left to join vessel on 29th Feb 2020 and it was received by my wife on 1st March.

Being a Seafarer, I will be away working on board for the next 2 to 3 months before coming back to S'pore.

I truly find that the medical claims of about \$\$10,000 is exaggerated too much plus others yet to be assessed, which I think all taxi drivers are trying to pull for a fast one. Right now I do not have any footprint coverage due to the timing for recovering the vehicle recording camera is rather too late thus resulting in overridden to indicate whether he or I am in the wrong as I am travelling along TPE in the 2nd lane towards exiting Tampines Avenue 10 and the other car on the inner 1st lane along TPE toward Changi Airport. It happened too fast and sudden that resulting in sliding damaged to each other.

After the sliding accident both moved our cars away form the site forward at a safe distance to clear all other traffics behind. During this stage both came out to assess our sliding damaged and exchange information.

Both of us has are normal and had not sustained any injury or pain, even he sounds normal when I talked to him over the phone the next day. No police report was made by me then because there isn't any human injuries or damaged of any Government property, until I received a traffic police notification on dated 8th Feb. 2020 that they are investigating into this matter, which I was advised to make a police report too at nearest Neighbourhood Police Post (Tampines)
