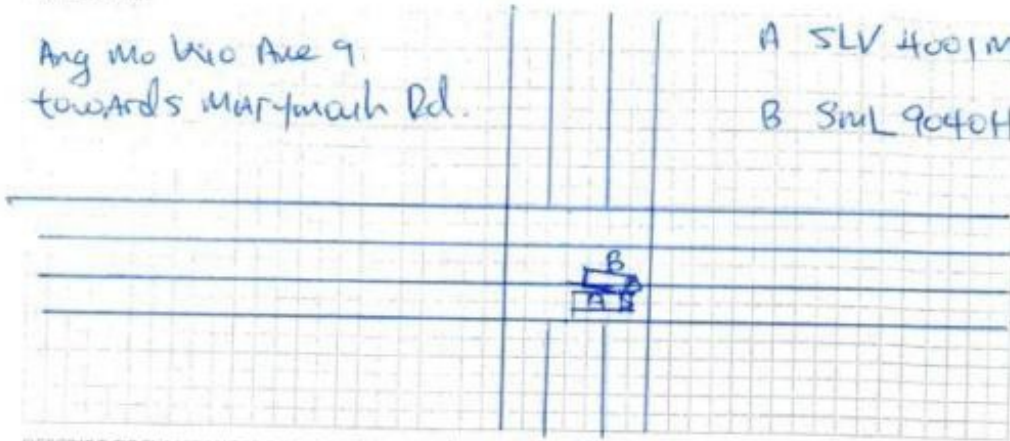
Accident Sketch Plan

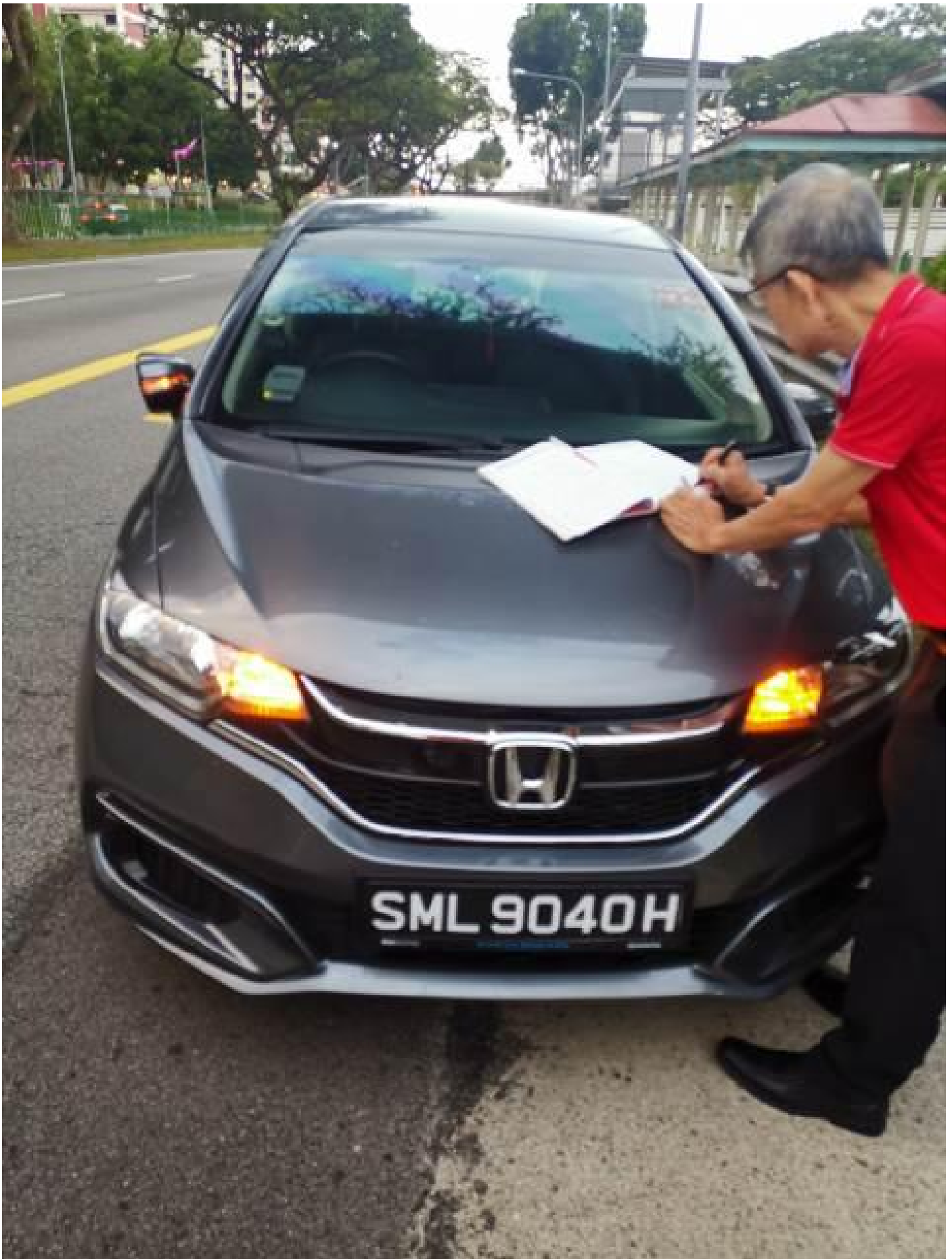

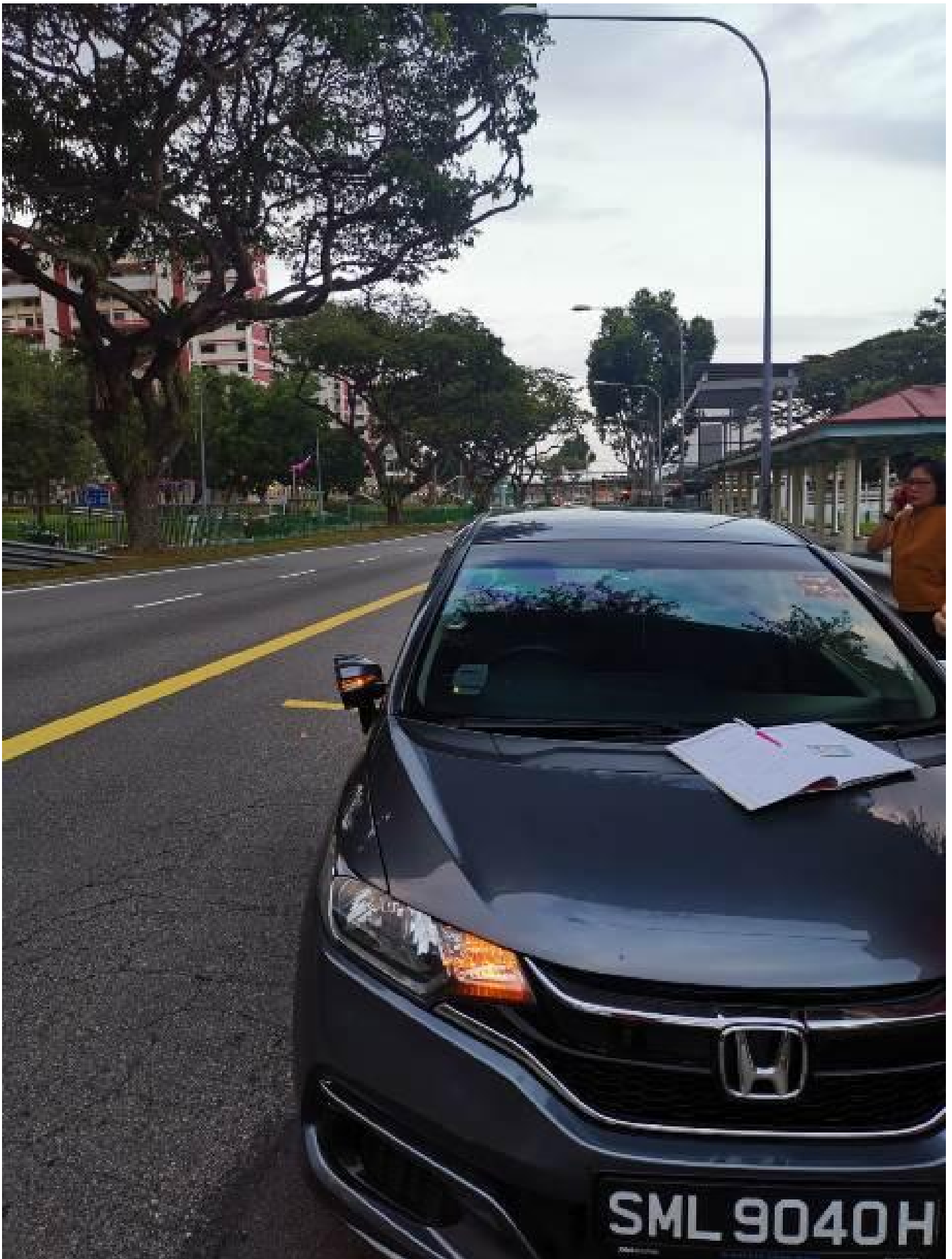
