



DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

I was driving SMG7099D on the 3rd lane going straight on Guillemard Road heading towards CITY when a white Bmw 93887 suddenly turned left from the centre lane (2nd lane) towards a turn-left lane towards Tanjong Katong Rd.

I was not able to brake in time to prevent the accident (although I jammed break). The driver is very apologetic and asked for private settlement to avoid losing his 50% NCD. I did not promise anything but agreed to proceed to his preferred workshop tomorrow (28th Jan) to assess the damage & cost.

If we could not agree to the private settlement, I wish to claim 3rd party insurance against him.
