Enclosed is the video footage for your investigation.

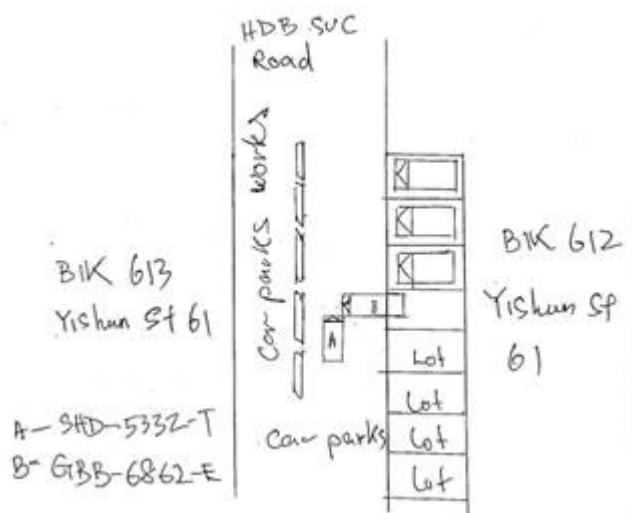
From the video, your client who suddenly came out from the parking lot without any signal and hit onto our taxi front portion.

Brief Details.

On 29/01/2020 at about 1155hrs, I was driving my taxi SHD 5332T along the carpark to pick up my passenger. While driving, there is another light goods vehicle with vehicle no. GBB 6862E that suddenly came out from the parking lot without signaling. The van then hit onto the front part of my taxi.

Subsequently, both of us went out from our vehicles and I wanted to exchange particulars however the driver refused to. The driver then told me to lodge a police report instead.
