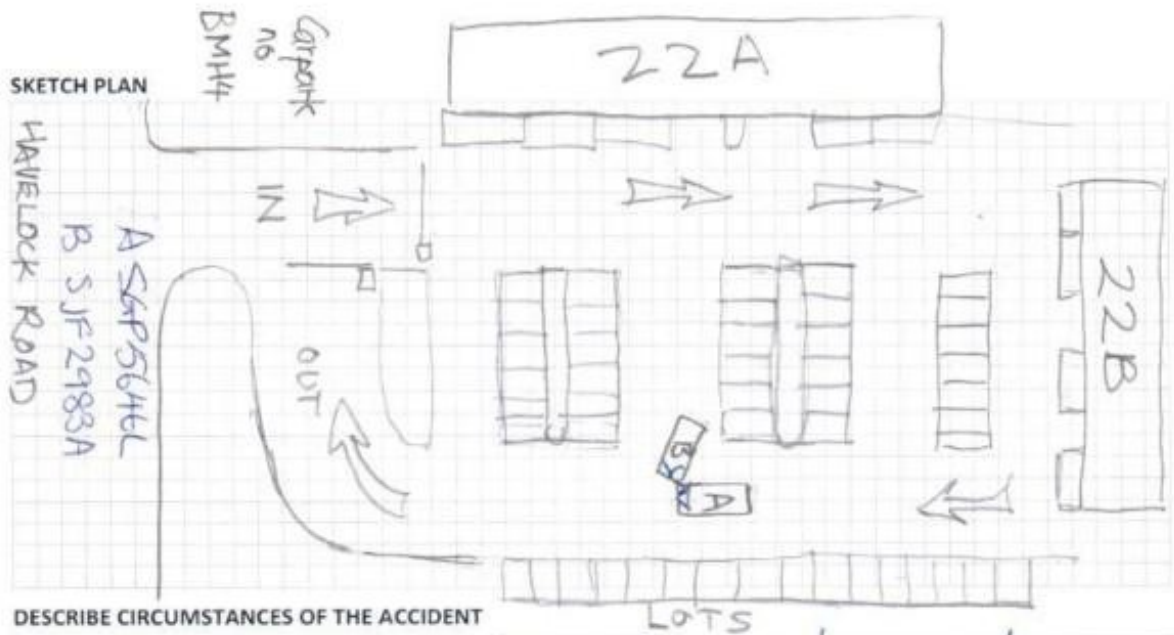

# Accident Sketch Plan


