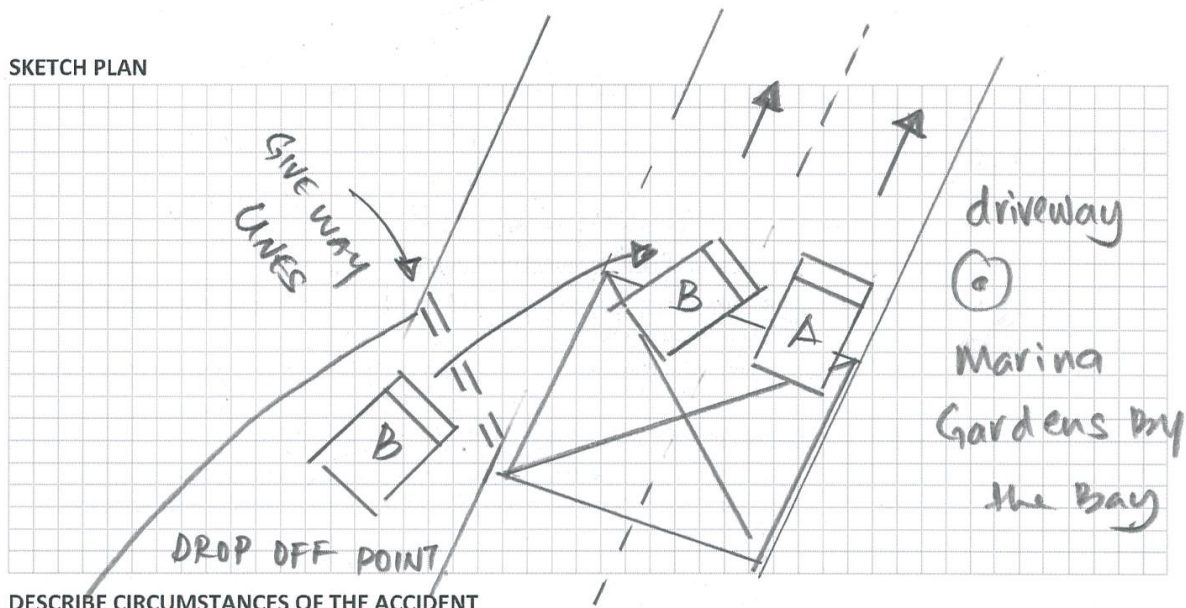

Describe Circumstance of the Accident.

ON 31/01/2020 @ 1025HRS, I WAS DRIVING MY TAXI (SHD 1410 C) – TRAVELLING ALONG THE DRIVEWAY @ GARDENS BY THE BAY – ON THE RIGHT LANE.

WHILE I WAS MOVING STRAIGHT AHEAD – SUDDENLY I FELT FROM MY LEFT.

WHEN INSPECTED, I DISCOVERED THAT VEHICLE B (SHA 2978 R – COMFORT TAXI) WHICH WAS EXITING FROM THE DROP OFF POINT (ON MY LEFT) – FAILED TO KEEP FOR PROPER LOOK OUT & FAILED TO STOP AT THE GIVE WAY LINES, HAD MOVED OFF AHEAD & ENCROACHED ONTO MY PATH ON MY LEFT ABRUPTLY.

AS SUCH, THE RIGHT FRONT OF VEHICLE B COLLIDED ONTO THE LEFT PORTION OF MY TAXI.

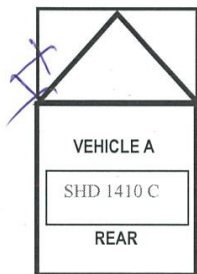

NO INJURY INVOLVED.

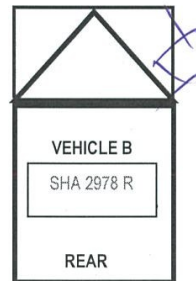
