Kindly provide us the video footage of the accident as your client mentioned that his car had an in-car camera, thanks.

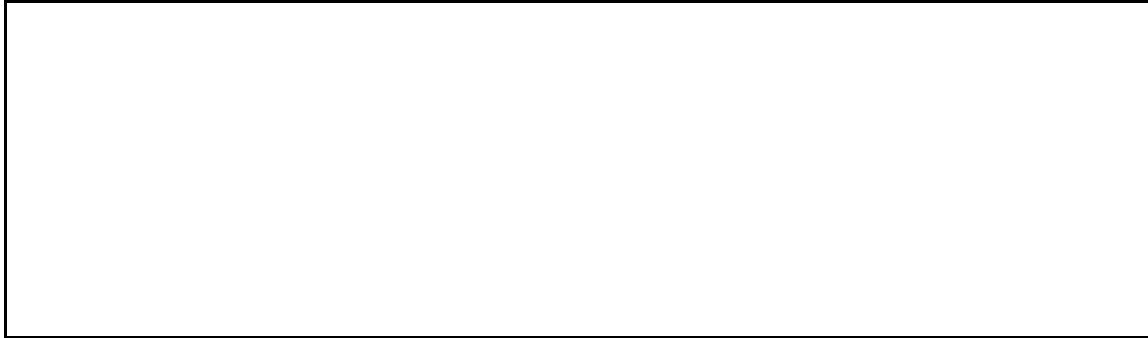
