This is pursuant to the inspection conducted on <u>05/02/2020</u> (date) at "the workshop".

We/I confirm that we/I are/am authorized by the owner **KINGZ BRIYANI PTE LTD** ("the third party claimant") of vehicle no. **SGU 3783K** make the claim as set out in the above paragraph and we/I have full authority to settle the matter on his/her behalf in a manner that we/I deem fit. We/I enclose herein the letter of authority given by "the third party claimant".

This Discharge Voucher applies only to the claimant's claim for his property damage and will not affect his personal injuries claim and/or uninsured losses claim in a later date. Further the settlement terms herein should not be used as an evidence to prejudice to the claimant's personal injuries claim and/or other uninsured losses claim arising of the subject matter in the action.
