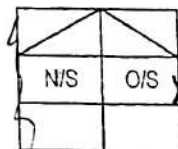

Brief Details.

On 22/01/2020 at about 1230hrs, I was riding my motorcycle bearing registration number V1) FBQ4364K outside MSCP of Block 986 Jurong West St 93. I was riding to enter the carpark gantry. Suddenly a car bearing registration number V2) SLP1987U came out of the exit gantry and collided on the rear right side of V1. V1 wobbled I fell to the left. Both my knees were bleeding due to the fall. I managed to get up and exchanged particulars with the driver of V2.

Passer-bys called ambulance and I was conveyed to NTFGH and was given 5 days of MC from 22/01/2020 to 26/01/2020. The damages to V1 are, left side mirror and clutch lever dented. Both left and right side safeguards dented and also scratches on the left and right side of the motorcycle.
