 - (ii) For complying with requirements under my regulations, laws or court orders.



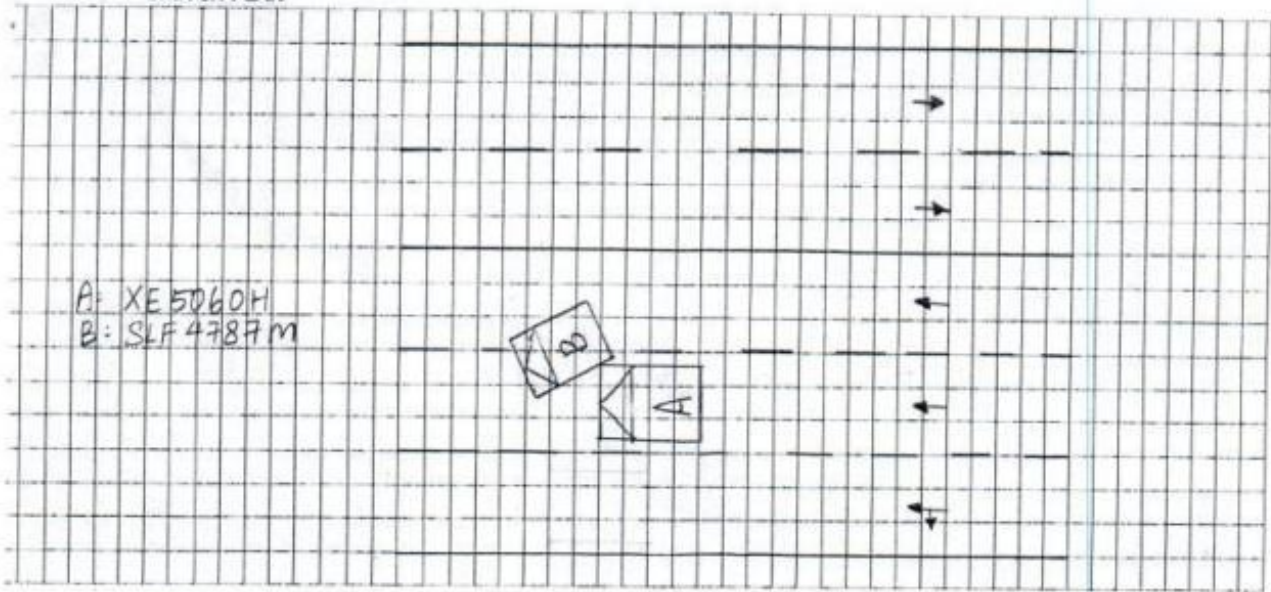

SKETCH PLAN

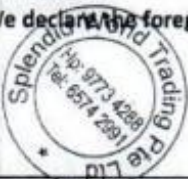


DESCRIBE CIRCUMSTANCES OF THE ACCIDENT
