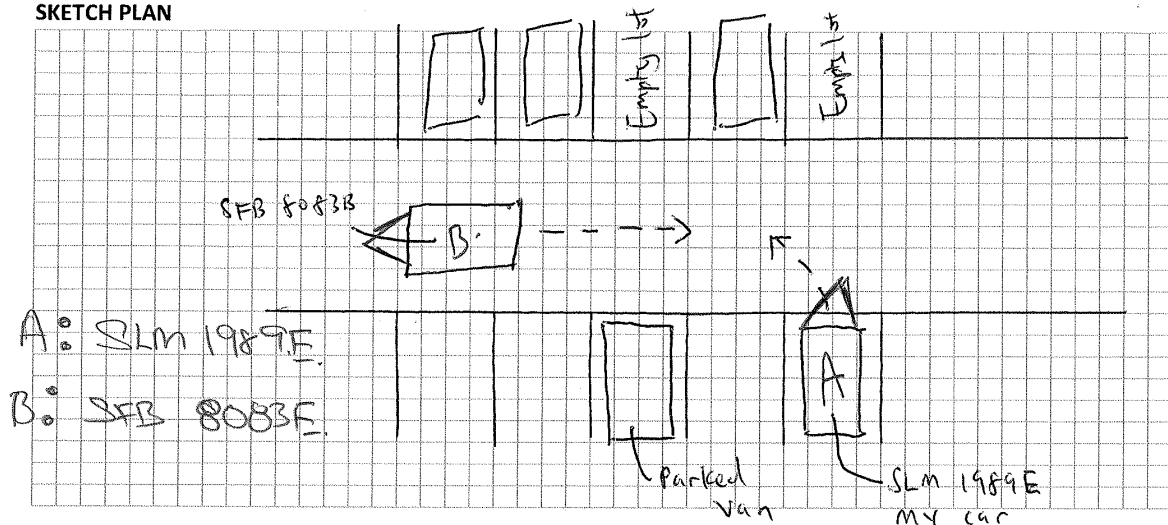

## DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

I, Yee Zi Liang Sidney (S8423218A) was ~~at~~ at the driver's seat in my vehicle SLM 1989E, with my wife Tan Ven Er (S8838184Z). Location was carpark beside Orange Valley Nursing home at Clementi Avenue 4. At approx 1426, we intended to move off from the parked position. I saw that blue Mazda SFB 8083B drove past without slowing, and when the road ahead was clear, I proceeded to move out of the lot. Due to a parked van in the adjacent lot, I was unable to see that SFB 8083B had stopped further up ahead, and was just starting to reverse into a lot. I stopped my vehicle to allow SFB 8083B to reverse into the empty lot closest to it.

However, SFB 8083B reversed straight along the road with speed, and hit my vehicle's front bumper left side, after I horned to warn the other driver. There was not enough time for me to react and take evasive action.

After the incident, I moved back into the lot to avoid unsafe condition. Both parties came out to check damage and exchange particulars.
