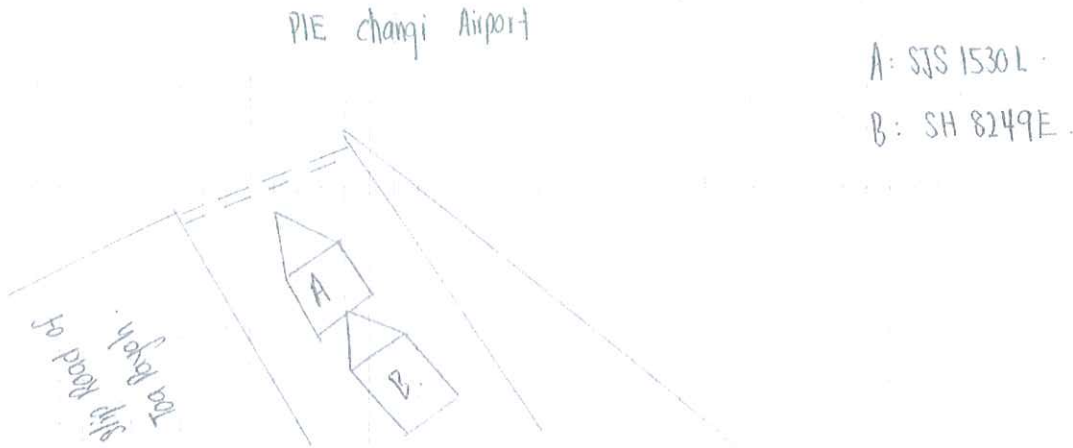

SKETCH PLAN






