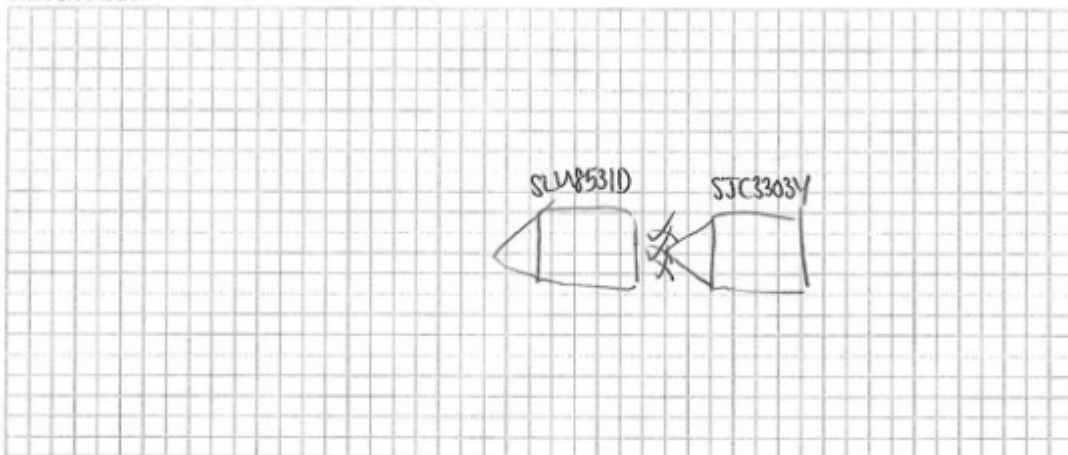

LOCATION: SLE (before exit 8A).

While driving along SLE before exit 8A, I was on the first lane. The traffic condition was quite heavy and the car in front of me suddenly came to a ~~brake~~ <sup>brake</sup>. I tried to brake but was not able to stop in time to avoid hitting the car in front me. I signalled to the car driver to move to the road shoulder, where we discussed, took photos of our accident, exchanged our driver's license and IC to take photos, and I gave her my contact number. She explained to me that it was the car in front of her that came to a sudden stop, resulting in her also jam braking. I also spoke to her dad over the phone, who instructed us to make a report of the accident.
