- 1. Dr Ho handed his vehicle over to Valet Tan Kim Meng (Tan) at about 1015hrs.
- 2. Tan parallel parked Dr Ho's vehicle in between 2 pillars (opposite lots 31 and 32).
- 3. Immediately after he parked and just before engine was switched off, the left side of the vehicle sank in.
- 4. Tan immediately came down from the vehicle and investigated. He realized that the drain covers had given way and the front left wheel of the vehicle had collapsed into the drain.
- 5. He immediately informed CRE Lee Chee Keong (Nelson). Nelson then informed Mervyn of FMD.
- 6. Dr Ho was informed via his staff who happened to be at the scene.
- 7. FMD do not have a jack to lift the tyre from the drain. As there were no other possible solutions, a decision was made to call for a tow truck.
- 8. Nelson engaged Island Recovery Services (IRS) for the job as Mervyn mentioned that MEH has no assigned vendor and there was no need to use an authorized agent by our insurers. Arrangements were then made with Desmond (from IRS).
- 9. Tow truck arrived at 1253hrs and vehicle was lifted from the drain at 1413hrs. Total cost incurred was \$120.00.
- 10. Nelson went to Dr Ho's clinic and spoke to both Cynthia (clinic staff) and Dr Ho. Apologies extended to both for the incident.
- 11. Nelson advised Dr Ho that he may send his vehicle to his preferred workshop and provide us with a quotation before commencing repair works.
- 12. Dr Ho mentioned that vehicle will be sent to Cycle and Carriage. He was upset and said that this is not the first time such incident occurred.
- 13. Nelson provided his email address to Cynthia for quotation to be emailed to.
