**CONTINUATION OF REPORT**

**Brief Details.**

On 14/02/20 at about 1930hrs, I was driving my vehicle SJV1763R with one passenger on board. I was driving along MCE > KPE (800m before Fort Rd exit) on the third lane of the five lane road. As I was driving, suddenly I felt an impact from the rear of my vehicle and I immediately applied my brakes. The back of my head hit hard on the head rest, and my passenger who was sitting diagonally, got his face hit on the front seat head rest. The accident caused the rear part of my vehicle to be seriously damaged and the rear windscreen to shatter. The rear bumper was also dislodged.

My passenger was conveyed to hospital via ambulance at scene. I felt pain at the back of my head and I went to Mount Alvernia Hospital to make a check on 15/02/20. I was given 5 days MC from 15/02/20 till 19/02/20.

Traffic Police was at scene as well.




