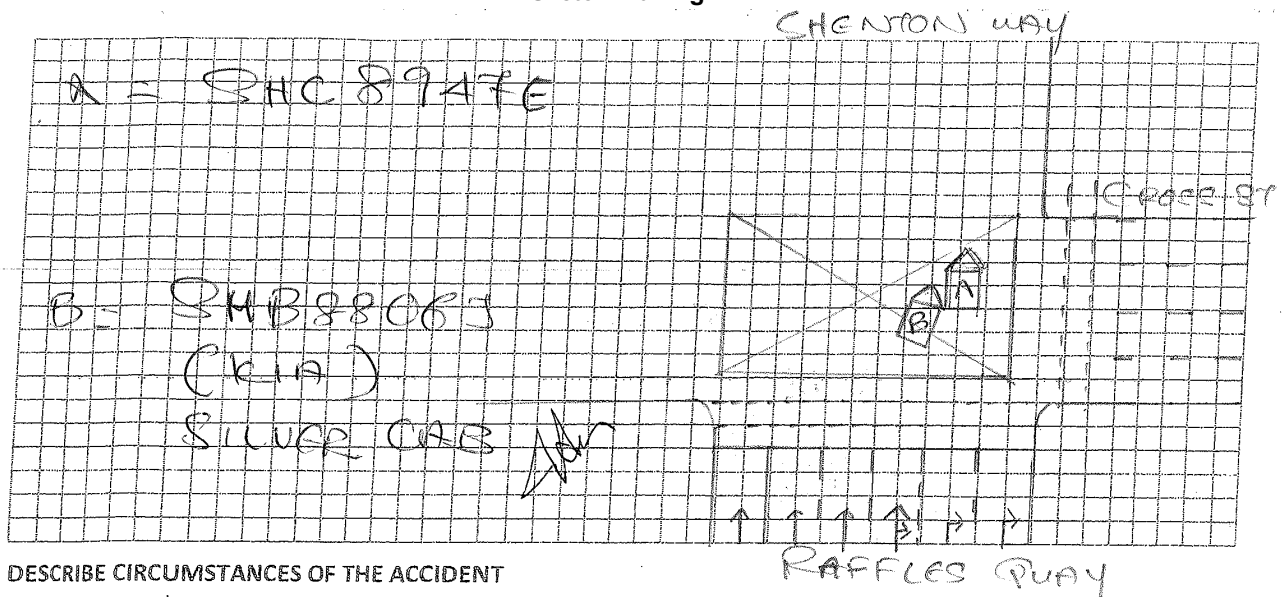

Describe Circumstances of the Accident.

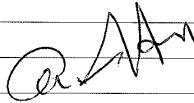
On the 11/02/2020 @ about 19:40rs, I was driving along Raffles Quay towards Shenton Way

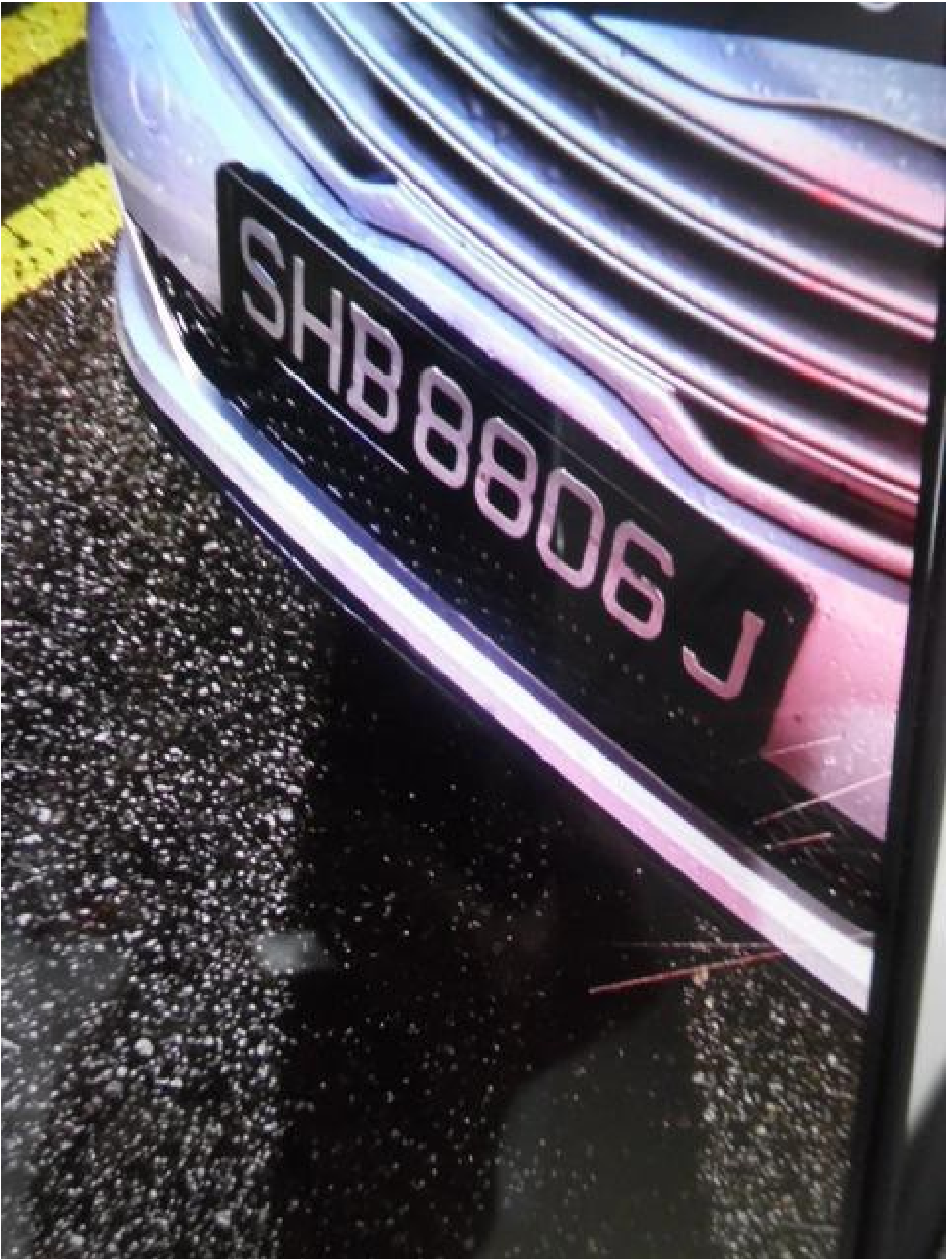

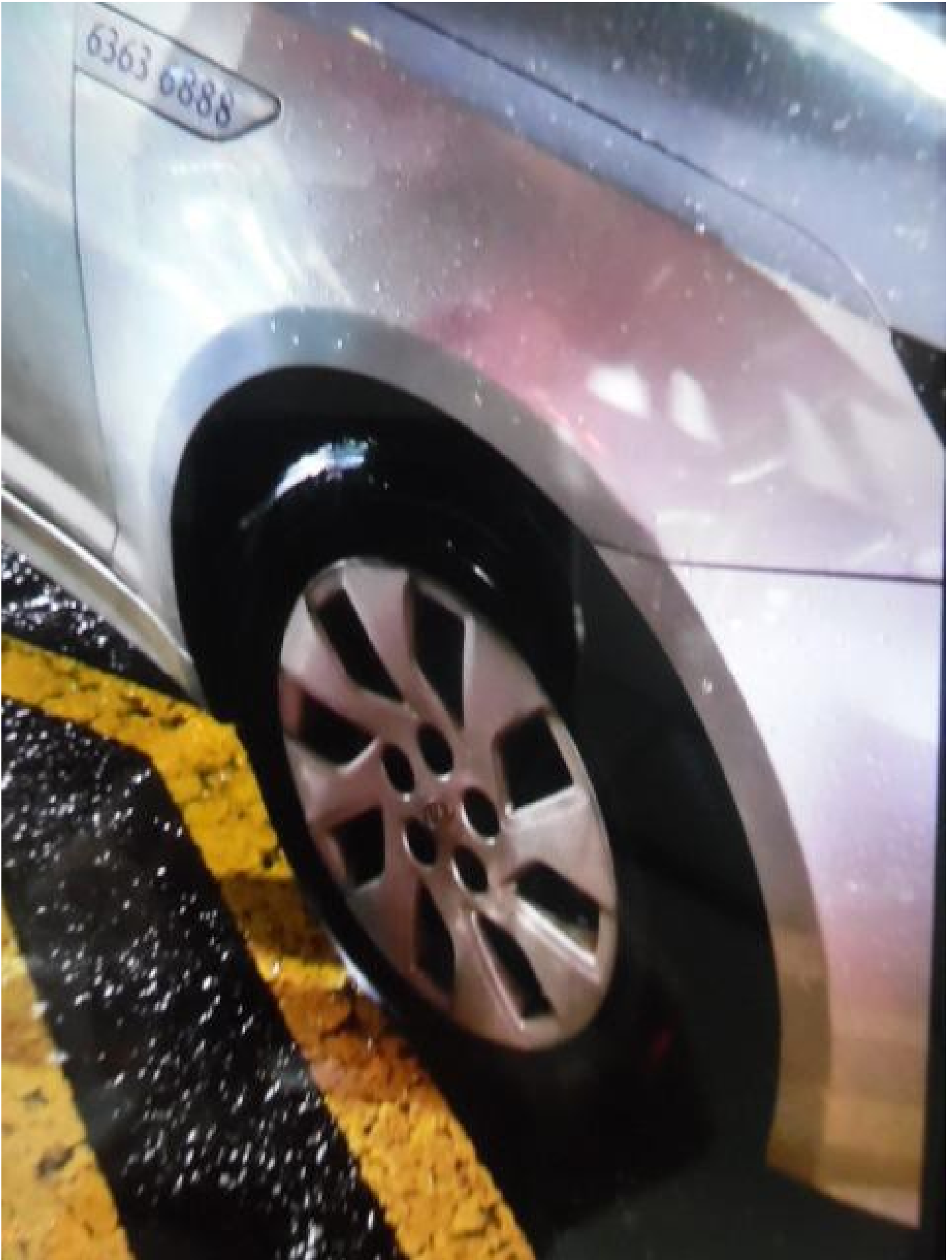
