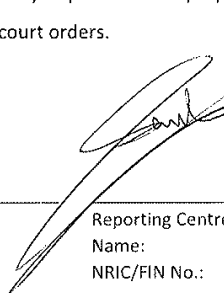

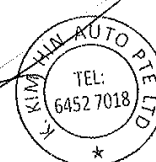
I understand, acknowledge, agree and consent that:

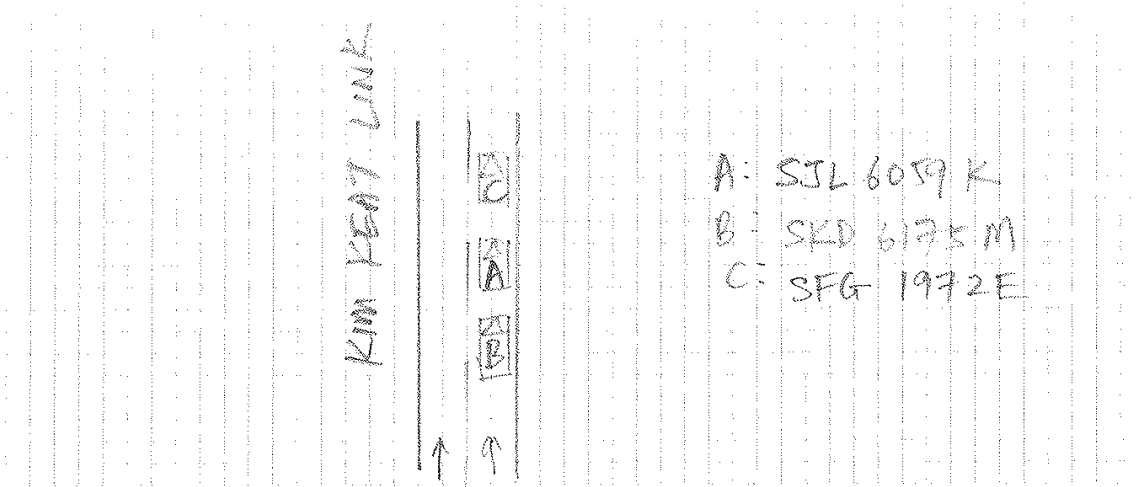

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

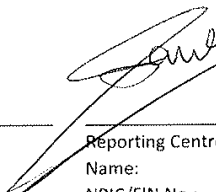
