Brief Details.

On 19/02/2020 at about 0930 hrs, I was driving a passenger from Johor Bahru into Singapüre. I dropfed off my passenger Queen St taxi terminal at about 1045 hrs. My taxi is a Toyota Innova HJA3132.

After dropping off the passenger, I headed back to Johor Bahru. After crossing Woodlands checkpoint, while on the linking brigde, I drove on lane 1. Lane 1 is normally a truck/bus lane however the normal practice is that public transport vehicles such as taxls would drive here if the traffic is heavy.

About 3/4 ways toward Johor Bahru, I wanted to change to lane 2. A yellow causeway link bus JSY6407 stopped and gave way for me. I thanked him and slowly changed to lane 2. While I was already more than halfway into lane 2, I heard a noise like someone had hit me from behind.

I then stopped my vehicle and got off to make a check. I noticed that my left rear door was scretched and defited. I then asked the driver of Mazda SLW5497D who hit me how to settle it. But he claimed that it within't his fault. As I did not want to hold up traffic any longer, I then told him we would settle it with the police. I then took some pictures and left.
