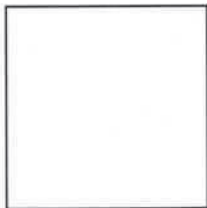

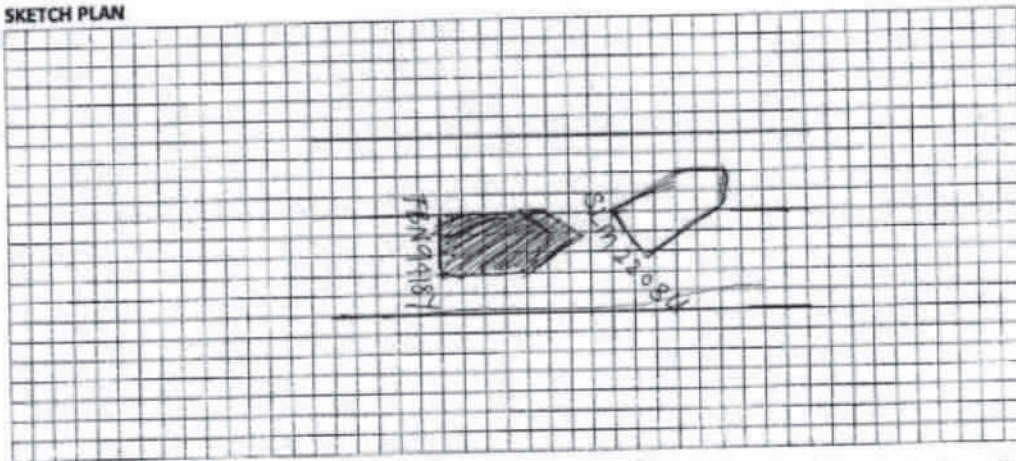

Brief Details.

On 14/02/20 at about 1500hrs, I was riding along the right most lane along PIE(Changi) before exit 8B when the red in colour Audi A1 (SLM2208U) in front of me made a quick swerve to the left and performed a hard braking immediately. I did not expect the car to swerve and jam brake and hence could not brake in time, even though I have slowed down in advance. Prior to the accident, I have noticed that the car was following the car in front very closely. My motorcycle and myself were flipped upon contact with the car's rear. After the collision, the driver alighted and called the ambulance for me. I was then conveyed to Changi General Hospital by ambulance.

I suffered abrasions on my body and bruises on my back as a result of the accident. I am also having headaches due to the accident as my helmet came off when I landed on the ground. I was given 7 days of medical leave after going through X-Ray and CT scan. The handle bar and fairings of my motorcycle were damaged and is now unable to be ridden.
