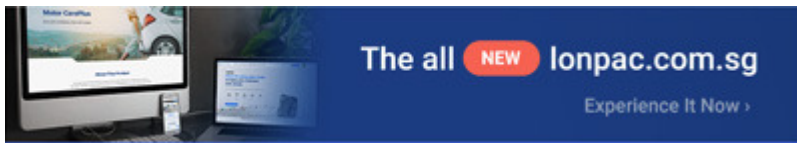

Dear Mr Kenny,

We refer further to the below email.

TP driver reported that our Insured vehicle rolled back and collided to the front portion of his vehicle.

Our Insured Driver reported that he was not aware of the accident.

As such, we had requested for any evidence from the TP repairer. There was no video footage available, however, photos were taken and were provided to us (see attached photos).

Based on the provided photos, it is likely that there was contact between both vehicles. However, it is not conclusive enough to prove if our Insured vehicle rolled back.

As such, in view of conflicting versions, we propose for a 50/50 liability or since TP can't prove that Insured vehicle rolled back, we will deny TP claim as per BOLA 27.
