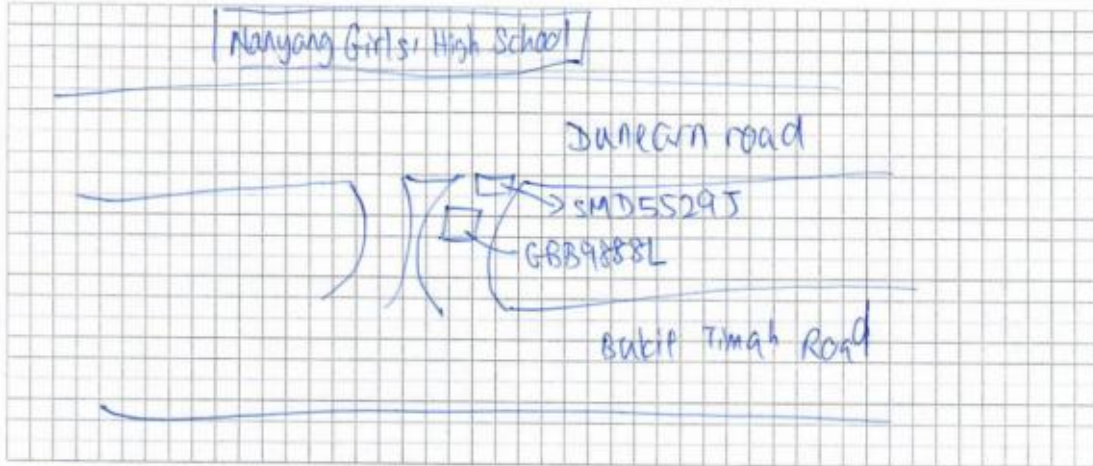

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

I was on the u-turn slip road turning from Bukit Timah Road to Juncarn Road in front of Nanyang Girls' High School. I saw that the on-coming traffic ~~at~~ along Juncarn Road had stopped at the Traffic Light just before the slip-road I was on. The Audi Q2 was in front of my vehicle. I thought the Audi Q2 would surely have moved off given the on-coming traffic along Juncarn Road had stopped at the Traffic Light. I checked ~~to~~ to my left once more to make sure the ~~the~~ vehicles had stopped before moving off. But when I turned back forward, the Audi Q2 was still there. It was too late to stop and my vehicle came into contact with the Audi ~~Q2~~ Q2's ~~rear~~ left rear. I did not step on the accelerator yet, but simply lifted my foot off the brake pedal and allowed my vehicle to inch forward.
