May I seek your assistance to perform a detailed mechanical inspection of the 2 vehicles below on an urgent basis, please.

- a) Case IAFP-IB-20191120 - Mechanical Inspection of Motorcycle, FBQ2458L (TP/IP/71957/2019)
- b) Case IAFP-IB-20191120 - Mechanical Inspection of Motor Car, SDX35B (TP/IP/71957/2019)

On 19 November 2019 (Tuesday) sometime before 8.41 p.m, the motorcycle; FBQ2458L was proceeding straight along East Coast Road towards the direction of Fort Road on green light only. Upon reaching the signalised cross junction of East Coast Road by Still Road South while the motorcycle was still proceeding straight on green light only, the motor car; SDX35B abruptly made a discretionary right turn on green light only. As such, the frontal portion of the motorcycle collided into the left rear portion of the motor car. Due to the accident, the rider sustained serious injury and was conveyed to the hospital by the ambulance. Morning panel directions were given to proceed for a thorough mechanical inspection on both vehicles.
