Brief Details.

On the 13/02/2020 at about 0935hrs, I left home ridding my motorcycle FJ5419U, Yamaha, red in colour along Anchorvale Link beside Nan Chiau Primary School and there is a taxi travelling in front of me. The taxi initially wanted to turn left after Nan Chiau Primary School however he went straight again. I wanted to overtake the vehicle initially however decided not to. Subsequently he went straight towards the traffic light junction of Anchorvale Link and Anchorvale Drive and I thought he is going straight to make a right turn to Anchorvale Drive. I then keep to my left and entered the filter lane to turn left into Anchorvale Drive to the coffeeshop at Blk 308 Anchorvale Drive. Suddenly I saw the taxi on my right and after exiting the filter lane, the said taxi was in front of me and made a sudden brake to a stop. I tried to swerved to the right to avoid collision with the said taxi however to no avail and I hit onto the rear of the taxi and I was flung onto the road. I only regain consciousness after a while and there is a passerby whom assisted to help me to turn me over as I could not move both my hands and I felt pain on my back. The driver of the said taxi also came to me and checked on me.

The Traffic Police and the ambulance arrived shortly and I was then conveyed to Khoo Teck Puat hospital for medical attention and I was warded for about 5 days. I was also advised by the Traffic Police to make a traffic accident report after I was discharged from the hospital. I was also unable to remember/ recall what is the taxi colour/ company or registration plate number. That is all.
