I refer to your email dated 29 November 2019.

We can carry out an inspection to check on the steering system and braking system of the PMD. This will be done through visual examination and operating of the PMD. We will put up a written report thereafter on our findings. Our fees will be \$450/- (excluding gst).

However, if there is dismantling required for example braking system not effective and require further checks, then the PMD would have to be brought to an external shop in Ang Mo Kio where some
