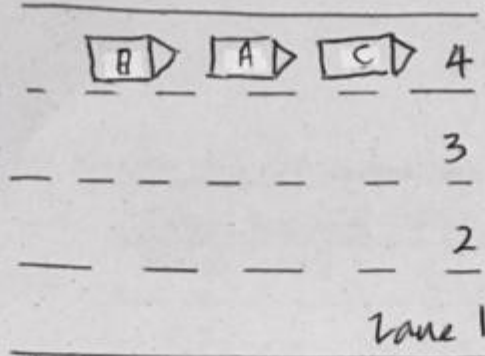

- (B) PC 3185A


DESCRIBE CIRCUMSTANCES OF THE ACCIDENT




