Accident happened on 22-02-2020 at around 13:27 hrs as the carpark exit gantry no of Clementi Mall Shopping Centre. I was at the gantry waiting to exit, but the exit gantry system was faulty. I pressed for help, the security officer came to me, straight away gesture asked me to ~~keep~~ reverse, I reverse quite a distance at that moment car SLR 9631H was behind me, he stay put and did not reverse back to keep a safe distance from me. The security then came to talk to me, he said my cashcard has not enough money, I told him nope and I took out my cashcard and try putting it back to prove I have sufficient cash in the card. He then asked me to pass to him my cash card. He try to manually insert my cash card to the gantry machine but he was unable to do so. knowing is gantry system faulty, he proceed to radio talk to the control station. After a short wait the gantry barrel opened. I noticed there are a long line of car behind me. So I proceeded to exit not realising I was still on reverse mode. Then my car bang onto SLR 9631H.
