

I WAS DRIVING ALONG ROBINSON RD, WHILE WAITING FOR THE TRAFFIC LIGHT, I WAS IN THE FIRST CAR. WE INTENDED TO TURN RIGHT INTO FINLAYSON GREEN. AFTER THE TRAFFIC LIGHT HAS BEEN TURNED GREEN, I WAS IN THE VERY SLOW MOTION TO TURN RIGHT, SUDDENLY THERE WAS A BIG COACH SLIGHT FROM BEHIND WITH A FASTER SPEED TO TURN RIGHT AND CUT INTO MY LANE AND HIT ONTO MY VEH LEFT HAND SIDE. I STOPPED MY VEH AND THE COACH DRIVER ALSO STOPPED.
