We have received a claim from Body Repairer/Workshop acting on behalf of the owner of SLF 2990E against your motor insurance policy.



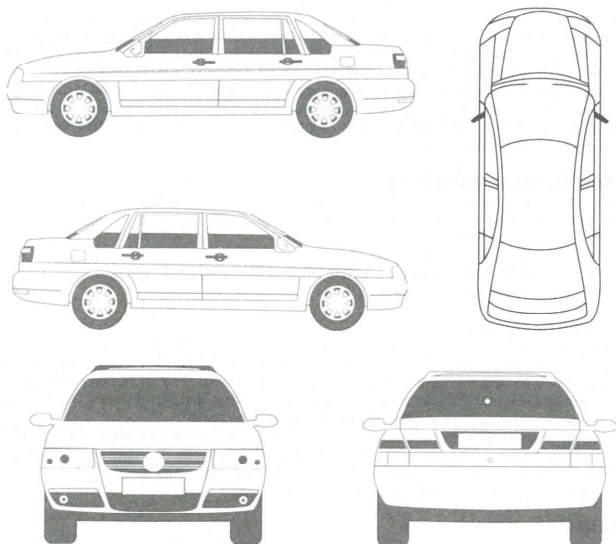
