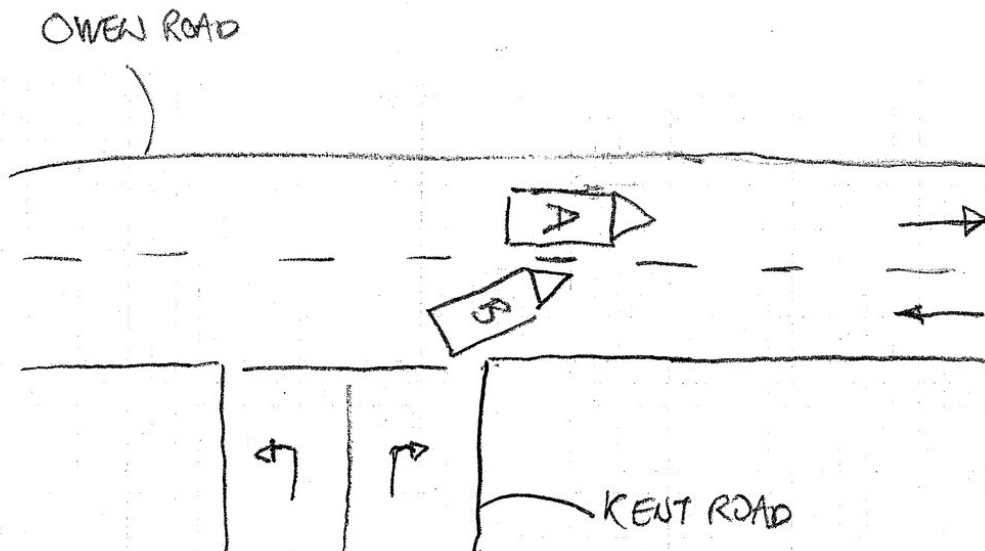

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

Authorized Driver (SCH6988H) in car A driving East on Owen Road at 11:00AM on Sunday 8 March 2020, at speed 25-30 km/h.

Car B (taxi, SH7347L) was turning right from Kent Road to Owen Road and hit Car A on Car A's back right hand side with Car B's front left hand side. Car B driver (ONG SIEW FO, I/C: 2076862B, H/P: 84381389) did not appear to be paying attention to traffic as car B was moving at normal speed but obviously did not check before turning from minor road to major road and ignored the white stop line on Kent Road.

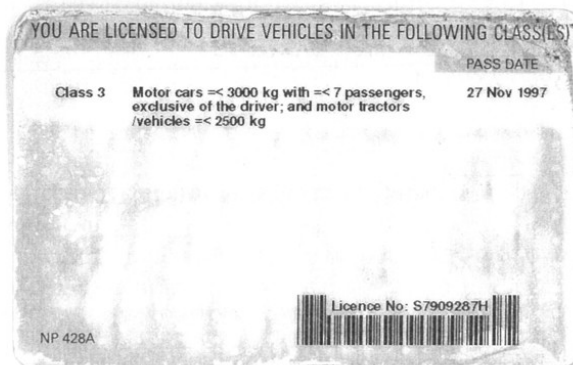
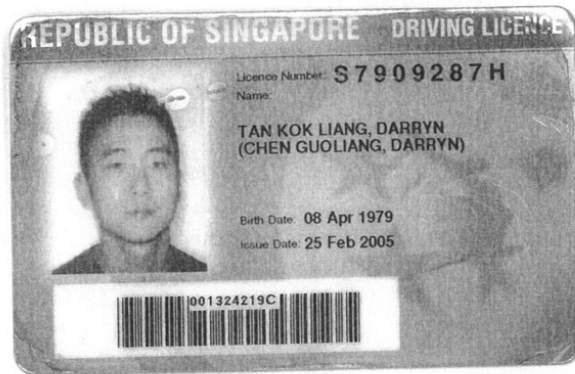
