Brief Details.

I have video footage onboard my motorcycle, the motorcycle FBJ8060Y is currently at TP compounds.

I was travelling along lane 1 of Hougang Avenue 3 from ubi towards Tampines road, my lane was clear as I was approaching this yellow box T-junction with HG24 carpark (if I am not mistaken), and I was certain I was travelling under 60 km/h.

I recall there was a 10ft lorry waiting before the yellow box in lane 2 as lane 2 was not clear. As I was passing the lorry, a car's bonnet suddenly protruded from in front of the lorry without warning. I braked and tried to evade but was unsuccessful, which resulted in my motorcycle colliding with the car's front right.

The impact tore off the car's front bumper and it went sliding along with me and my motorcycle on lane 1 before coming to a stop later.

I had a broken lower left leg and was attended to by by passers before being conveyed to Tan Tock Seng Hospital by ambulance.
